**INSPECTION FEES**

Regular Time – Cost will be billed at the current hourly rate for the employee and equipment involved, plus fringe benefits and overhead.  
Overtime – Costs will be billed at 1.5 times the current hourly rate for the employee involved, plus the regular rate for the equipment involved, plus fringe benefits and overhead.  
Consultant Inspection Rates – Cost will be billed at an hourly rate per Annual Bids received

*Inspection Charges will be billed on a monthly basis using an itemized statement. The Applicant will be liable for any and all Fees.*

**TRANSPORTATION PERMITS**

***Oversize (Per Motor Unit) \*\****

- Up to 13’11” High, 14’ Wide, and/or 80’ Long
  - Single/Roundtrip/Multiple (Within 3 Days)..... \$25
  - Annual..... \$80

***Overweight & Oversize up to 13’11” High, 14’ Wide, and/or 80’ Long (Per Motor Unit) \*\*\*,\*\*\****

- Up to 25% over Normal Legal Axle Weight per Axle
  - Single/Round Trip/Multiple (3 Business Days)..... \$25
  - Annual..... \$80
- Up to 40% over Normal Legal Axle Weight per Axle
  - Single/Round Trip/Multiple (3 Business Days) ..... \$25
  - Annual..... \$80
- SUPER MOVE More than 40% over Normal Legal Axle Weight per Axle - *At LCRC Engineer’s Discretion*
  - Single/Round Trip/Multiple (3 Business Days) ..... \$80
  - Annual..... *At LCRC Engineer’s Discretion and/or Lapeer CRC Board Approval*

***Mobile Home Transportation Permit***

- Single Move or Round Trip (Within 3 Days)..... \$50
- Annual..... \$80

***Restricted Road Permit (Posted Roads) - At LCRC Engineer’s Discretion***

- Up to Class “B” weights (3 Day Permit)..... \$40

***Rubbish Hauler Frost Law Exemption.....\$100***

- Trucks with a Minimum of 3 Rear Axles ONLY

***Seasonal (Frost Law Exemption)..... \$50***

- Agricultural, Milk Haulers, Public Utilities & Emergency Well-Drilling Only

\* Dimensions shall be measured from the widest points including overhangs. Mobile homes shall be allowed an overhang up to 8” (14’8” total width).

\*\* Oversize and Overweight permits shall be issued for non-divisible loads only. A permit shall not be valid for any vehicle with a load that can be readily dismantled, reduced or rearranged to come within the legal limits.

\*\*\* Maximum load on any axle shall not exceed 700 pounds per inch of tire width.
